The heading is the administrative/organizational portion of a resolution and contains the name of the committee, the topic, and the names of the sponsoring countries, the countries that are signatories, and the committee code. The body of a resolution is written as a long sentence, and starts with the name of the committee, followed by a comma.

A resolution is a main motion that needs to be expressed formally in writing, to attach a special level of importance. Because of the form — beginning with the word Resolved and following with either a statement of opinion or a statement authorizing or directing some action — such a motion is called a resolution.

Title of a Funeral Resolution. The title of the funeral resolution is usually centered at the top of the page and includes the deceased's name. Some samples of titles are: Resolution of Respect for Name of Deceased; Resolution in Loving Memory of Name of Deceased; Introduction to Funeral Resolution.
